Sub: Construction of Road Over Bridges ROB's at 3 Locations i.e. Igatpuri-Bhusawal Section at LC No. 147- km 418/27-419/01 between Shirsoli-Jalgaon Stations, LC No. 95 - km 205/17-19 between Kherwadi-Odha Station and LC No. 149 - km 422/04-06 between Jalgaon-Bhadli Station in Lieu of LC Gates in Maharashtra area on Bhusawal Division of Central Railway.- **Revision in Eligibility & Qualification Criteria & Validity of Offer.**

Following clause shall be incorporated in subject tender:

i. Section 8; Eligibility & Qualification Criteria

(A) 8.4 Eligibility criteria for ROB Construction in MRIDC

MRIDC is aiming to construct large number of ROB's simultaneously to complete them on fast track basis. MRIDC is executing large number of ROB's spread in different location in Maharashtra State. As every ROB site is unique and hence required individual supervision for adequate quality and completion of work on time. Therefore, awarding multiple ROB work to an agency/firm in single entity or in JV is not desirable for fast track implementation of projects.

In the light of this, following additional eligibility criteria is to be fulfilled by the bidder for being eligible for opening of financial bid.

"Upper limit of award of contract by MRIDC to any Joint Venture /constituent member of JV/ Partnership Firm / Sole proprietorship firm as single entity or in a JV is 14 ROB's work under one or more than one contracts".

The Bidder/s must have Available/Balance ROB capacity equal to or more than the total number of ROB's in the present tender. The available ROB capacity shall be calculated as under:

$$\text{Available/Balance ROB Capacity} = 14 - R$$

R= Maximum number of ROB's in hand of the bidders, awarded for construction by MRIDC.

Even though the bidders meet the qualifying criteria mentioned in para 8.1 to 8.3 above, they shall be disqualified if they are not fulfilling the ROB capacity criteria i.e. the available MRIDC ROB capacity of bidder is less than the total number of ROB's in the present tender.

ii. Section 3; Instructions to Bidders

3.7.1 Validity of Offer in case of Negotiation: In case of negotiation held with Lowest eligible bidder (L1), the negotiated offer/latest negotiated offer of bidder shall be valid up to 60 days from the date of negotiation or 120 days from the opening of technical bid whichever is later.

Other terms & conditions of above said tender will remain unchanged. The corrigendum shall be part of the tender document.
