## SECTION 7

### ELIGIBILITY AND QUALIFICATION CRITERIA

This section contains all the criteria that MRIDC will use to evaluate Bids and qualify Bidders through post-qualification. No other factors, methods or criteria shall be used other than specified in this bidding document. The Bidder shall provide all the information requested in the forms included in Annexures.

#### 7 Evaluation

##### 7.1 Adequacy of Technical Proposal

Evaluation of the Bidder's Technical Proposal will include an assessment of the Bidder's technical capacity i.e. experience of having executed similar nature of work as detailed in the following paras.

##### 7.2 Technical Eligibility Criteria:

The Bidder must have successfully completed / substantially completed at least 3 detailed structural design during last 07 (seven) years, ending last day of month, previous to the month in which tender is invited for "Detailed Structural Design & Consultancy services completed for Cable Stayed Bridges consisting of steel composite superstructure and span more than 200 m" in India or Foreign shall be considered technically eligible.

**Successfully completed:** It shall mean, that the work must be satisfactorily completed in all respect.

**Substantially completed:** Contracts for which detailed design services are completed by the Consultant and has been approved by the Client. But association during execution of work may be ongoing.

**7.3** The Contractor has to submit certificate duly verified by Client whether the work is **successfully completed or substantially completed** and in case of substantially completed work, the issued certificate from client should clearly indicate the scope of the work completed.

In case, if the certificates submitted by Firm /Agency is found to be false / forged or incorrect at any time after the award of contract, it will lead to termination of the contract, along with forfeiture of Retention Money and Performance Guarantee besides any other action provided in the contract including banning of business with MRIDC for five years from the date of such order.

#### 7.4 Minimum Eligibility criteria for Key Personnel:

2	Senior Bridge Design Engineer	02	M.Tech / M.E. /M.S in Structural Engineering from recognized University.	Min 15 years of experience. <b>Specific Experience</b> - Should have experience in designing of minimum 3 Cable Stayed Bridges of span more than 200 m and at least one with steel composite deck.
3	Bridge Design Engineer	02	M.Tech / M.E. /M.S in Structural Engineering from recognized University.	Min 10 years of experience. <b>Specific Experience</b> – 8 years in Design of long span Bridges across Railway / Roads /Rivers / Creeks; and Strong understanding of applicable Codes & Standards.
4	Sr. Quantity Surveyor	01	B.Tech / B.E. in Civil Engineering from recognized University.	Min 8 years of experience. <b>Specific Experience</b> – 5 years in quantity estimation, rate analysis etc for highway / flyover / bridge/ elevated road projects.
5	Quality & Control Engineer	01	B.Tech / B.E. in Civil Engineering from recognized University.	Min 8 years of experience. <b>Specific Experience</b> – 5 years in the relevant field for cable stay bridge / flyover/ Bridge / elevated road projects.

**7.5** Documents testifying bidder's previous experience, key personnel and financial status should be produced along with the tender.

Bidder(s) shall submit along with his / their tender:

- i. Certificates and testimonials regarding contracting experience for the type of job for which tender is invited with list of works carried out in the past.

- ii. Certificates which may be an attested Certificate from the client, Audited Balance Sheet duly certified by the Chartered Accountant etc regarding contractual payments received in the past.
  - iii. The resume submitted by the Bidder shall be mandatorily signed by the Key personnel to whom the resume belongs and countersigned by the authorized representative of the Bidder
