Maharashtra Rail Infrastructure Development Corporation Limited (MRIDC), having its corporate office at 2<sup>nd</sup> Floor, Hoechst House, NCPA Road, Nariman Point, Mumbai- 400 021, India, which is a Joint Venture of Government of Maharashtra and Ministry of Railways, for implementation of various Railway Projects in the territory of Maharashtra.

The aim of setting up this Joint Venture Govt., Company is to provide a boost to the Rail Infrastructure Projects in the Maharashtra State on the principle of cooperative federalism. There are several regions in Maharashtra State, having long pending demands for construction of new Railway lines, Gauge Conversion, Doubling of Rail Line & Construction of Road Over Bridges. There is need for development of Rail Infrastructure of critical connectivity and capacity enhancement in the State of Maharashtra. Accordingly, it is aimed to identify, develop and implement such Rail line projects.

MRIDC has been entrusted with the responsibility of implementation of Gauge conversion project of Nagpur-Nagbhir Section of South-East Central Railway.

MRIDC is inviting online bids (e-Tender) in two packet system from eligible tenderers for execution of **"Construction of civil works i.e. Earthwork, blanketing, Major & minor bridges, Wildlife Mitigation Structures, Road Under Bridges (RUB)/ Limited Height Subway (LHS), retaining walls, drains, ground improvement works, cement concrete lining, cross drainage works, relocation of existing roads & utilities, Providing & fixing of Over Head Equipment mast etc. including all Chord lines, shunting, Isolations/sand hump/cross overs etc. in all the station yards in connection with Gauge Conversion Work between Itwari and Nagbhir Section in Nagpur Division of South East Central Railway."**
