

14. EVALUATION OF CREDENTIALS FOR EMPANELMENT:

The Firms / Agencies/ Contractor shall be empanelled with MRIDC for the subject empanelment based on their following details:

- Geographical Presence or Address (i.e. ease of accessibility of the Firm from Mumbai, Maharashtra).
- Year of establishment (Incorporation certificate to be attached).
- Similar works Completed by the Firm in last 7 Years counting from the last day of the preceding month in which EoI is invited.
- Experience in "**Fabrication, Supply and Launching** of Composite and other Steel Plate Girders as well as Open web steel girders and Bow String Girders for similar work".
- **Fabrication** - Length of span, nos. of span & quantity (in MT) executed by the Firm for similar work in last 7 Years counting from the last day of the preceding month in which EoI is invited.
- **Launching** - Length of span, nos. of span & quantity (in MT) executed by the Firm for similar work in last 7 Years counting from the last day of the preceding month in which EoI is invited.
- Work in Progress with date of Award, Target Date of completion, Cost of work & Payment received till last day of the previous month in which EoI is invited (This statement shall be duly certified by Chartered Accountant).
- Financial Turnover (relevant work experience only) / contract receipts during last 7 Financial years.
- Average Annual Turnover (relevant work experience Only) shall be calculated based on the Financial Turnover of last seven Financial Years. Year in which no turnover is shown would also be considered for working out the average turnover/In case of missing data for any financial year, the average annual turnover shall be calculated considering "Zero" as the annual turnover for that particular financial year and same shall be certified by the Chartered Accountant.
- Equipment, Plant & Machineries available with the Firm for the specific purpose.
- Self-certified copy of Bank Solvency Certificate issued from Nationalised or any Schedule Bank. The certificate should have been issued within 3 months from original last date of the submission of the EoI.

Note:

- 1) In case of Partnership Firm, each partner must provide jointly and severally, details of similar nature of work completed during last 7 Years counting from the last day of the preceding month in which EoI is invited, Work in Progress and Financial Strength in the Form Provided in EoI.

- 2) MRIDC reserves its right to evaluate and finalise the Empanelment list without considering the application of any party undergoing insolvency resolution process or liquidation or bankruptcy proceeding under the Code regardless of the stage of Empanelment process.

15. EVALUATION CRITERIA AND METHOD OF EVALUATION:

The Shortlisting of Firms shall be done based on the marks obtained by the firm after evaluation of firm's experience, credentials etc. Screening of EoIs shall be carried out as per criteria decided by MRIDC and based on testimonials submitted. EoI will be evaluated for shortlisting inter alia based on their past experience of handling similar nature of work by the Firm during last 7 Years counting from the last day of the preceding month in which EoI is invited, strength of their man power & qualification, financial strength of firm, Work in Progress, Year of establishment, Geographical Presence, Equipment, Plant & Machineries available with the Firm for the specific purpose and presentation / proposal to the selection / evaluation committee whose decision will be final.

However, MRIDC reserves the rights to redefine the marking process & Evaluation Criteria based on the data provided by various agencies / Firms. In such situation MRIDC's decision will be final and binding.

16. SIMILAR WORK:

Fabrication, Supply and Launching of Composite and other Steel Plate Girders as well as Open web steel girders and Bow String Girders having, minimum 18 m of span, **completed** for Railway Line Projects, Highway Projects, Metro projects, High Speed/Semi High-Speed Railway Line Projects with any Government, Semi Government, Public Sector Undertaking (PSU) organisation or any Private organisation of repute, shall be treated as similar work.

The firm may have experience of similar works through one contract or multiple contracts.

Applicant and in case of Partnership Firm each partner, jointly & severally must provide details of similar nature of work completed during last 7 Years counting from the last day of the preceding month in which EoI is invited.

All work experience and data provided should be substantiated by documentary evidence such as completion certificate / work order copy / LOA copy etc.
